



Waiver & Release

As legal guardian of _____, and in consideration of participation in Ninja Zone through IGI Gymnastics (hereafter referred to as IGI), I represent that I understand the nature of this activity and my minor child(ren) is/are qualified, in good health, and in proper physical condition to participate in Ninja Zone. I acknowledge that if I believe conditions are unsafe, I will immediately discontinue my child(ren)'s participation in the activity. I fully understand that this activity involves risks of serious bodily injury, including permanent disability, paralysis and death, which may be caused by my child(ren)'s actions or inactions, the actions or inactions of other participants, the conditions in which the event takes place, or the negligence of the "releases" named below. I fully accept and assume all such risks and all responsibility for losses, cost, and damages I incur as a result of my child(ren)'s participation in Ninja Zone.

I hereby release, discharge, and covenant not to sue IGI or Ninja Zone, its respective administrators, directors, agents, officers, volunteers, employees, other participants, sponsors, advertisers and, if applicable, owners and lessors of premises on which the activity takes place (each considered one of the RELEASES herein), from all liability, claims, demands, losses, or damages on my account caused in whole or in part by the negligence of the "releases" or otherwise, including negligent rescue operations and future agree that if, despite this release, waiver of liability, and assumption of risk I, or anyone on my or my child(ren)'s behalf, makes a claim against any of the Releases, I will indemnify, save, and hold harmless each of the Releases from any loss, liability, damage, or cost, which any may incur as the result of such claim.

Any and all Ninja Zone skills will be conducted in a safe gym environment and I will hold IGI and Ninja Zone harmless of any injuries incurred in and outside of gym areas.

I have read the Release and Waiver of Liability, Assumption of Risk, and Indemnity Agreement, understand that I have given up substantial rights by signing it and have signed it freely and without any inducement or assurance of any nature and intend it to be a complete and unconditional release of all liability to the greatest extent allowed by law and agree that if any portion of this agreement is held to be invalid the balance, not withstanding, shall continue in full force and effect.

I also hereby authorize IGI and Ninja Zone to publish the photographs and videos taken of me and/or my child (ren), and our names, for use in the printed publications, website and training purposes. I release IGI and Ninja Zone from any expectation of confidentiality for my child(ren) and myself and attest that I am the parent or legal guardian of the child(ren) listed and that I have the authority to authorize the use of their photographs, videos and names. I acknowledge that since participation in publication and websites produced by IGI and Ninja Zone is voluntary, neither my child(ren) nor I will receive financial compensation. I further agree that participation in any publication and website produced by IGI or Ninja Zone confers no rights of ownership whatsoever. I release IGI and Ninja Zone, its contractors and its employees from liability for any claims by me or any third party in connection with my child(ren)'s participation.
